- A registration **fee for each tournament of One Hundred dollars** (\$100.00), such fee to be paid at the time the Lake is reserved for the tournament.
- Each boat participating in the fishing tournament must obtain and display an appropriate Mozingo Lake Access Permit sticker. A **fee of nine dollars** (\$9.00) **per day** is charged for daily permits. Each tournament will have the option of prepaying for permits and having predated ones mailed to the tournament director; or having a representative for the group purchase the permits during normal business hours (Monday-Friday, 8am-5pm) within 3 days of their tournament date. Boats with current Season Permits will not need a daily permit.
- The aforementioned applicant and his party hereby agree to comply with the Park rules and regulations and all applicable statutes and ordinances governing the Mozingo Lake Park facilities.
- Fishing tournaments may begin no earlier than thirty (30) minutes prior to sunrise and must be concluded within eight (8) hours of starting time. (NEW)
- Fishing tournaments scheduled during the period of July1 to August 31 must be concluded no later than 1:30 p.m. (NEW)
- Tournament results must be e-mailed or mailed to the Recreation Coordinator within 72 hours of each tournament, so that we may report fishing stats to the Missouri Department of Conservation. (NEW)
- The applicant further agrees that the City of Maryville shall have the authority to revoke a fishing Tournament Permit upon reason to believe there has been a violation of any park rules or ordinance or law or upon good cause shown.

- Applicant agrees to apply for and obtain all required permits or licenses necessary for the special event as described within this permit.
- The applicant hereby agrees that, if the Fishing Tournament Permit is granted, it shall be granted only for the event as specifically detailed within the permit application. Any alteration or deviation from the event as described shall authorize the City to immediately terminate the Fishing Tournament Permit and the closing of the facility to the participants.
- Applicant further agrees to furnish the City of Maryville any additional information which it deems necessary to properly review this Fishing Tournament Permit tournament.
